# SCRIP

The SCRIP program had total sales of \$265,467, which was \$25,883 more than last year. Cost of Goods Sold was \$251,434, which was \$25,385 more than last year.

Gross profit was \$14,110, which was \$570 more than last year.

Net income was \$130, which was \$8,063 better than last year.

Families who had purchased SCRIP for their children in Most Precious Blood School or Faith Formation lowered their tuition by \$3,676, which was \$2,166 less than last year. An additional \$10,000 was given to the Parish as the yearly stipend.

# **ST.VINCENT DE PAUL**

The Most Precious Blood Conference of the Society of St. Vincent de Paul was started on August 11, 2015. Four parish members made up the Vincentians of the MPB Conference. The Society is a Catholic voluntary organization of lay people, men and women. It seeks, in a spirit of justice and charity, to help those who are suffering or deprived. Vincentians serve the poor cheerfully, listening to them and respecting their wishes, helping them to feel and recover their own dignity. In the poor, they see the suffering Christ.

MPB serves the New London school district area. Thirty-nine families requested assistance during this time with ninety-eight children and adults being helped with \$6,400 given for rent assistance, food, and utilities. The funds come from a stipend from the Appleton store's profits, the Thanksgiving collection, and donations from parish members.

# PCCW (Parish Council of Catholic Women)

The Parish Council of Catholic Women (PCCW) is composed of all women of the parish over the age of 18. The purpose of this organization shall be to offer all women of the parish opportunities for service, friendship, spirituality, and education in addition to assisting the pastor in spiritual projects for the welfare of the parish. The PCCW is a member of the Vicariate III North in the Green Bay Diocese as well as a member of the Green Bay Diocesan Council of Catholic Women (DCCW), and National Council of Catholic Women (NCCW). The PCCW Mission Statement is: The MPB PCCW acts through its members to support, empower, and educate all Catholic Women in Spirituality, Leadership, and Service. MPB's PCCW programs respond with Gospel values to the needs of the Church and society in the modern world. Our members work in the ministry of the church by serving as Eucharistic ministers, lectors, musicians, cantors, and sacristans. We pray the rosary with parish members at Most Precious Blood funerals, serve funeral dinners, and support the MPB kitchen. Our main source of revenue comes from our Resale Shop that takes place on a weekly basis. The Resale Shop is supplied by donations from the community. This outreach program has helped many families in need of clothing and household items. Due to the diligent work of ladies that run our resale shop and its continued success, we can give generously to a diverse

group of organizations including:

Community programs: a Knight takes the donated food from Church to the Food Pantry, donated money to the Food Pantry, donated money to a wheelchair program, \$1000 Scholarship to NLHS, and donation to VIDA.

Family programs: lead the marriage prayer during February and St. Joseph Icon.

Faith programs: church bulletin donation, St Lawrence Seminary School donation, Carmelite Ministry of St Teresa donation, Military Archdiocese donation, Spiritus donation, Masses said for deceased Council members, at least one Knight is at all Adoration hours with four Knight at most of the Tuesday Adorations.

Life programs: donations to Pro-Life gala, and \$1,000 toward an ultrasound machine which are located near abortion clinics.

Fundraising was done through tootsie roll drive, State charity raffle, breakfast, pizza sale and brat fries.
